1. The application form submitted by the school is signed by the Deputy Commissioner, Kendriya Vidyalaya Sangathan without stamp. Therefore, the school is required to submit an application on a prescribed format (copy enclosed) the same is duly countersigned alongwith stamp and forwarded by the Competent Authority of the School i.e. Kendriya Vidyalaya Sangathan.
2. The school may ask to intimate the subjects to be introduced for Senior Secondary classes.
3. The school is required to submit an attested copy of certificate relating to Health and Sanitation of the school obtained from the Competent Issuing Authority.

Further necessary action in the matter only is initiated after the receipt of compliance of above points.
